Promotion of AIPPI

(e.g. meetings with governmental organisations, talking about AIPPI at Universities) After the in-presence event that followed the general assembly in 2024 our group organised a dinner with the panelists, coming from italian IP courts, the UPC, the Italian Privacy Authority, the Academia and the Industry. Representatives of other Italian institution were invited. An Italian translation of the resolutions adopted at the Istanbul Congress was spread among the Italian IP Courts and other Italian institution.

Our national group contributed to the organization of the Unified Patent Court's inaugural event, which took place in Milan on July 1, 2024. In November, it participated in the Flash Mob on the International Day for the Elimination of Violence Against Women. Strict collaboration with the Italian Patent and Trademark Office, the Order of Consultants, the Milan, Brescia and Rome Bar Associations, AGCOM (Italian Communication Authority), the Advertising Self-Discipline Institute and AGCM (Italian Antitrust Authority) and Italian privacy Authority during the year.

The cooperation with the Bar Association was, as usual, particularly intense. Cristiano Bacchini continued to chair the IP and Antitrust Committee of the Milan Bar, in which several of our associates participate, including President Lavagnini.

Alessandro Bura	I'm a member of AIPPI Privacy and Counterfeiting Standing Committee.
	On March 12, 2025, I participated on behalf of the Italian Group to a meeting on new developments in On-line Commerce, Customs, Boarder Protection.
Andrea Comelli	I have been appointed as a member of the Patents Standing Committee in late May 2024, and attended the quarterly meetings ever since. During the AIPPI Midterm Meeting in Zagreb I have participated in the preliminary meeting for the evaluation of a possible joint study between several committees on particular cases of IP rights infringement via the Internet.

The Questionnaire was circulated on December 2024. I shared it with the Italian Group to collect its responses.

Lorenzo Micacchi	I'm a member of the Amicus and observer of the IP and Sustainability standing committees. Regarding the Amicus SC, I I joined it in May 2024 and actively participated to its meetings. I contributed in drafting the proposal for an amicus brief in the case G 1/24 before the Enlarged Board of Appeal of the European Patent Office, which AIPPI submitted to the EPO through the SC on November 15th, 2024. Regarding my activity as observer of the IP and Sustainability SC, I attended the online meetings, participating personally to the meetings in Madrid and Hangzhou. I also renewed my observer participation this year, taking part in one of the subcommittees on Sustainable enforcement of IPRs.
Francesca Morri	I'm a member of the PVR Committee since the beginning. I regularly attend the meetings, participating actively. On July 2024 I made a presentation about the Italian case "sun world" (Italian Supreme Court, April 9, 2024). I attended the first meeting in presence of the PVR Committee that was held during the AIPPI World Congress in Hangzhou.
